India, People's Republic of China, Holders of Hong Kong Document of Identity, Macau Special Administrative Region (MSAR) Travel Permit, Georgia, Turkmenistan, Ukraine, Commonwealth of Independent States (Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Uzbekistan), Democratic People's Republic of Korea.

The following countries are required additional Form V39A (download)

Nigeria, Mali, Afghanistan, Algeria, Bangladesh, Egypt, Iran, Iraq, Jordan, Lebanon, Libya, Morocco, Pakistan, Somalia, Sudan, Syria, Tunisia, Yemen, and holders of Palestinian Authority Passport, Temporary Passport issued by the United Arab Emirates, Refugee Travel Document issued by Middle-East countries and Kosovo.

COLLECTION PROCEDURE

Collect in-person. Otherwise, original letter of authorization letter signed by the applicant, indicating the name and identity card number of the authorized person and a copy of the identity card of the authorized person.
